

Inquest into the deaths arising from the Lindt Café siege

Non-publication and access restriction orders made by the State Coroner on 22 May 2017 with respect to claims notified by the Commissioner of New South Wales Police arising from the submissions of the Commissioner of New South Wales Police and members of the NSW Police Force, save for Officers A and B

Until further order, pursuant to s. 74(1)(b) of the *Coroners Act 2009* (NSW):
