

# Inquest into the deaths arising from the Lindt Café siege

## Non publication orders made by the State Coroner on 5 and 21 September 2016: application by the family of Katrina Dawson

1. Until further order, pursuant to s. 74(1)(b) of the *Coroners Act 2009* (NSW) there be no publication of:
  - a) the document titled 'Certificate of Analysis' in relation to Ms Katrina Dawson, dated 23 December 2014 (Tab 2.4);
  - b) the second bracketed word on the 16<sup>th</sup> line of page 6022 of the statement of 'Sasha' (Tab 14.21);
  - c) the second, third and fourth words in the ninth line of the paragraph titled 'Brief Description' on page 8648 of the transcript of the walkthrough interview with 'Delta 2' (Tab 20.47);
  - d) the 13<sup>th</sup> to 16<sup>th</sup> words (inclusive) on the fifth line of page 8692 of the investigator's note summarising the walkthrough interview with 'Delta 2' (Tab 20.48);
  - e) the final three words on the 12<sup>th</sup> line of page 3125 of the medical records of Marcia Mikhael from Royal North Shore Hospital (Tab 30.25);
  - f) the following words contained in the statement of Chris Ennis (Tab 30.29):
    - i. the final 5 words on the third line of paragraph 30;
    - ii. words contained in the fourth line of paragraph 30; and
    - iii. the first 11 words of the fifth line of paragraph 30;
  - g) the following words contained in the statement of Matthew Pepper (Tab 30.30):

  - i. the final three words on the 15<sup>th</sup> line of the second page (page 3346);
  - ii. the first word on the sixth line of page 3349;
  - iii. the final word on the 19<sup>th</sup> line of page 3351;
  - iv. the words comprising the 20<sup>th</sup> line of page 3351;
  - v. the final three words on the 11<sup>th</sup> line of page 3352;
  - vi. the first three words on the 13<sup>th</sup> line of page 3352;
  - vii. the words comprising lines 13 to 18, inclusive, of page 3356;
  - viii. the words comprising lines 23 to 35, inclusive, of the 'Admission Summary' on page 3366; and
  - ix. the words comprising lines 1 to 14, inclusive, on page 3367;

- l) the following words in the statement of Detective Senior Constable Ben Sharkey (Tab 30.39):
  - i. the fourth to the 18<sup>th</sup> word on the ninth line of paragraph 12;
  - ii. the tenth line of paragraph 12; and
  - iii. the final bracketed word on the tenth line of page 3433.
- m) the fourth to tenth words (inclusive) of the second line of paragraph 1/b1 contained in the expert report of Dr Anthony Brown (Tab 35.9):
- n) the following paragraphs in the statement of Detective Sergeant Richard Crimmins (Tab 32.5):
  - i. paragraphs 65 to 68, inclusive, including the list of exhibits contained therein; and
  - ii. paragraphs 72 to 79, inclusive, including the list of exhibits contained therein;
- o) the following words in the expert certificate of Karla Kiprovich (Tab 32.13):

  - iii. the eighth to 18<sup>th</sup> words (inclusive) on the fifth line of the second paragraph on page 3635, under the heading 'XF000280366'; and

- iv. the sixth line of the second paragraph on page 3635 under the heading 'XF000280366';
    - q) the first line of page 10 contained in the documents relating to Acting Deputy Commissioner Jeffrey Loy (Tab 11.5F).
2. Until further order, pursuant to s. 65(4) of the *Coroners Act 2009* (NSW), the document titled 'Final Autopsy Report' relating to Ms Katrina Dawson (Tab 2.3), not be supplied to any person, except for:
  - a) the legal team assisting the State Coroner in this inquest;
  - b) Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner in this inquest;
  - c) the legal representatives of the parties to this inquest and their clients; and
  - d) the policing experts from the United Kingdom assisting the State Coroner in this inquest.
3. Until further order, pursuant to s. 65(4) of the *Coroners Act 2009* (NSW), the content referred to in Orders 1(i) and 1(l)-1(p) not be supplied to any person, except for:
  - a) the legal and clerical team assisting the State Coroner in this inquest;
  - b) Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner in this inquest;
  - c) the parties granted leave to appear in this inquest;
  - d) the legal representatives of the parties granted leave to appear in this inquest; and
  - e) the policing experts from the United Kingdom assisting the State Coroner in this inquest.
