

Inquest into the deaths arising from the Lindt Café siege

Non publication orders made by the State Coroner on 25 and 26 July 2016: application by the family of Katrina Dawson

Pursuant to s. 74(1)(b) of the *Coroners Act 2009* (NSW), there be no publication of:

1. The words comprising the fourth and fifth sentences of paragraph 17 of the statement of Detective Senior Constable Paul Horton dated 15 January 2015 (Tab 9.114);
2. The last 22 words of the first bullet point of subparagraph nine of paragraph 41 of the statement of the Category 1 officer of the New South Wales Police Force known by the pseudonym 'Sasha' in these proceedings dated 11 February 2015 (Tab 14.20);
3. The words comprising the final sentence of paragraph 23 of the statement of **Greg** dated 3 February 2015 (Tab 19.27);
4. The following words from the transcript of the walkthrough interview of the Category 1 officer of the New South Wales Police Force known by the pseudonym 'Alpha 2' in these proceedings (Tab 20.17):
 - a. the last 14 words of the second full sentence on page 55 of the transcript; and
 - b. the fifth to 17th words (inclusive) of the eighth full sentence on page 61 of the transcript;

 - b. the last eight words of line 22, and the first seven words of line 23, on page 28 of the transcript;
 - c. the sixth, seventh and eighth words of line 5 on page 34 of the transcript; and
 - d. the first six words of the 11th line on page 34 of the transcript;
6. The following words from the document titled 'Investigator's note summarising walkthrough interview with [Delta 2]' (Tab 20.48):
 - a. the second, third and fourth words of line 12 on page 8688; and

- b. the third, fourth and fifth words of line eight on page 8692;
7. The following words from the transcript of the walkthrough interview of the Category 1 officer of the New South Wales Police Force known by the pseudonym 'Delta 3' (Tab 20.50):
 - a. the last two words of line nine on page 41 of the transcript;
 - b. the words comprising lines ten and 11 on page 41 of the transcript; and
 - c. the first four words of line 12 on page 41 of the transcript;
8. The words comprising the second and third sentences, and the words comprising the last sentence, of paragraph 16 of the statement of [REDACTED] **RBDU 3** dated 13 January 2015 (Tab 23.4);
9. The following words from paragraph nine of the statement of [REDACTED] **RBDU 5** dated 16 January 2015 (Tab 23.6):
 - a. the words comprising the third sentence of paragraph nine;
 - b. the first eight words of the fourth sentence of paragraph nine; and
 - c. the words comprising the final sentence of paragraph nine;
10. The last six words of the first sentence of paragraph 21 of the statement of the Category 1 officer of the New South Wales Police Force known by the pseudonym 'RBDU 6' in these proceedings dated 12 January 2015 (Tab 23.7);
11. The words comprising the sixth sentence of paragraph 68 of the statement of Detective Senior Constable Amos Chan dated 8 July 2015 (Tab 26.30);
12. The following words from the statement of Detective Senior Constable Ben Sharkey dated 21 January 2015 (Tab 30.39):
 - a. the last five words of the fifth sentence of paragraph 12;
 - b. the words comprising the final sentence of paragraph 12; and
 - c. the last word of the tenth line of page 74 of handwritten notes appearing on page 3433.
