

Inquest into the deaths arising from the Lindt Café siege

Non publication orders made by the State Coroner on 14 February 2017

1. Until further order, pursuant to s. 74(1)(b) of the *Coroners Act 2009* (NSW) there be no publication of:
 - (a) The following words contained in the statement of Daniel Trincado (Tab 30.31):
 - i. the first two words on the fourth line of paragraph 26;
 - ii. the final twelve words on the fourth line of paragraph 26; and
 - iii. the words contained on the final line of paragraph 26.

 - b. Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner in this inquest;

- c. the parties granted leave to appear in this inquest; and
- d. the policing experts from the United Kingdom assisting the State Coroner in this inquest.
