

Inquest into the deaths arising from the Lindt Café siege

Orders made by the State Coroner on 27 June 2016 and 28 June 2016 with respect to the transcript dated 13 May 2016 and in chambers on 27 March 2017, 31 March 2017 and 6 April 2017 with respect to further claims notified by the Commissioner of New South Wales Police on 10 March 2017

1. In accordance with the closed court, access restriction and non-publication orders made on the application of the Commissioner of the New South Wales Police Force, pursuant to s. 65(4) of the *Coroners Act 2009* (NSW), the following information contained in the transcript of the proceedings dated 13 May 2016 is not to be supplied to any person except for those persons listed in Schedule B to those orders:

 - b. the words comprising line 34 on page 3964;
 - c. the first five words of line 35 on page 3964;
 - d. the last 14 words of line 37 on page 3964;

 - f. the words comprising lines one and two on page 3965;
 - g. the last 11 words of line eight on page 3965;
 - h. the words comprising lines nine and ten on page 3965;
 - i. the last seven words of line 20 on page 3965;
 - j. the words comprising lines 21 and 22 on page 3965;
 - k. the last ten words of line 36 on page 3965;
 - l. the words comprising lines 37 and 38 on page 3965;
 - m. the first four words of line 39 on page 3965;
 - n. the words comprising lines 42 and 43 on page 3965;
 - o. the last ten words of line nine on page 3966;
 - p. the first nine words of line ten on page 3966;
 - q. the last five words of line 23 on page 3966;

- r. the words comprising lines 24 to 32 on page 3966;
 - s. the last four words of line 35 on page 3966;
 - t. the first six words of line 36 on page 3966; and
 - u. the second, third and fourth words of line 49 on page 3970.
2. In accordance with the closed court, access restriction and non-publication orders made on the application of the Commissioner of the New South Wales Police Force, pursuant to s. 74(1) of the *Coroners Act 2009* (NSW), there is to be no publication of the following information contained in the transcript of proceedings dated 13 May 2016:
- a. the fifth and sixth words of line eight on page 3945; and
 - b. the words comprising lines 32 to 34 (inclusive) on page 3947.
3. In accordance with the orders made on 22 March 2016, the pseudonym 'Steven' be inserted into the transcript of proceedings dated 13 May 2016 to replace the following words, which comprise the name of a Category 1 officer of the New South Wales Police Force:
- a. the first word of line 36 of page 3904; and
 - b. the fifth word of line 50 on page 3904.
